Dr Caesar holds a PhD in Management and Commerce from the University of Tasmania (specifically the Australian Maritime College), Australia. His PhD work focused on the human capital issues within the global maritime industry. He is a member of the Decision Science Institute (DSI) and the International Association of Maritime Economists (IAME).
